Presidential Column

By adopting new byelaws at the Conference in Helsinki in 2011, the European Society for Child and Adolescent Psychiatry entered a new phase in its history. It is a nonprofit association, whose aim and purpose is to promote the mental health and wellbeing of children, adolescents and their families, to improve the quality of their lives and to ensure children's right to good mental health through appropriate preventive and therapeutic mental health services and interventions. In order to achieve each of these goals ESCAP will be adapting its organizational structure.

A key objective is to foster best clinical practice based on scientific evidence in the field of child and adolescent psychiatry and mental health. Allied to this is the need to encourage and support research in the field, promote research training and the continued expansion of the scientific base of child and adolescent psychiatry and mental health, to encourage and support educational programs in child and adolescent psychiatry, and through staging scientific congresses, high level meetings and publications, disseminate information and research findings. It is vitally important to collaborate with other organizations engaged in public health advocacy so as to promote the importance of mental health in Europe.

ESCAP is a federative body of national societies for Child and Adolescent Psychiatry in European countries (according to WHO definition). ESCAP has 32 members stretching all across Europe from Portugal to the Ukraine. These 32 members, notwithstanding their diverse cultural backgrounds, differing levels of service development and scientific research capabilities are committed to the aims of the Society. ESCAP has formulated its aims into three main areas and adopted a new structure that will facilitate achievement of its goals. The new structure is comprised of three divisions, namely Academic, Clinical and Policy. The role of the Academic Division is to act as a forum for exchange of scientific research and to promote education and training, especially research training. The role of the Clinical Division is to promote the quality of clinical practice in the field of child and adolescent psychiatry. The role of the Policy Division is to promote health policies, increase public awareness and advocacy related to the mental health of children and adolescents, and in so doing increase the standing and position of the Society both in Europe and within the European Union.

Fostering best clinical practice based on scientific evidence is a core objective of ESCAP. The increase in both quantity and quality of scientific output of European researchers in child and adolescent psychiatry in the last two decades has made it possible to organize the ESCAP Congresses not once in four years but every two years, since the ESCAP Congress in Florence in 2007. The Congresses in Budapest 2009 and Helsinki 2011 were driven by a powerful International Scientific Advisory Board with many of the top European researchers as members. The dissemination of **"Scientific Research"** has always been at the front of what the ESCAP congresses strive to offer.

In the coming years, Dublin in 2013, Madrid (2015), and Geneva (2017) we will endeavor to broaden the program of content of congresses guided by our newly expanded goals. In Dublin we will place greater emphasis on evidence based care, that will make the program even more relevant for clinicians working in our field, including psychiatrists, psychologists, social workers and others such as teachers and youth workers. "Quality of care" will be an important

component of the program we plan to deliver. This will be one step in broadening the scope of our congresses on into the future.

An allied objective is to focus on the topic of **"Policy".** How do we foster development of appropriate services that will deliver quality care for young people who need help and support and coordinate developments across European countries?

The ESCAP Congress in Dublin, July 6th–10th 2013 will be both interesting and stimulating, an opportunity to learn

about the latest research, up-to-date information on quality of care and policy developments, a forum for meeting and interaction and exchanging ideas among clinicians, scientists, and policy makers so as to promote the mental health wellbeing who are in need of our care.
