Coordination Center for Mental Health of the Cabinet of Ministers of Ukraine (hereinafter referred to as the Coordination Center) expresses its respect to you.

The Coordination Center is an advisory body to the Government of Ukraine, which supports the implementation of the All-Ukrainian Mental Health Program initiated by the First Lady of Ukraine, Olena Zelenska.

## ESCAP on transition

- The transition from adolescent to adult mental health services represents a critical period of vulnerability, that must be managed carefully and seamlessly.
- WHO data from 2016/2017 shows that under half (47%; n= 25/53) of countries reported to have guidance in place to facilitate the transition from child to adult mental health services, while just over one-third (33%; n=18/53) did not; no response was provided by the remaining ten countries (19% n=10/53)
- (WHO Regional Office for Europe, 2018).

## ESCAP Guidance on Transition

Guideline development uses clear evidence from the existing literature, and expert opinion (3). The ESCAP clinical guidance on transition was developed in three main stages: 1) An outline of the review and guidance was developed based on the review of other relevant and related clinical guidelines and guidance documents and reviewed by the ESCAP clinical division board; 2) Review of existing literature based on systematic literature searches and drafting of guidance; 3) Consultation with clinicians (from a total of X European countries), and (former) patients and parents; and 4) Revision of guidance based on feedback.

# 10 recommendations

1. **Start early: at approximately 6 months before the service boundary**
2. **Multidisciplinary approach**
3. **Involve young people**
4. **Include parents/caregivers**
5. **Foster respectful, person-centred care**
6. **Developmentally appropriate support**
7. **Holistic perspective**
8. **Transition coordination** Where available, involve **navigation services**
9. **Information sharing**
10. **Consider best communication tools**

## Ongoing projects

- **ADHD:**
  - The ESCAP Research Academy has now done a Survey structured around three key areas: 1) the use of psychostimulants and other medications for ADHD; 2) access to non-pharmacological therapies and educational support; and 3) socio-cultural perspectives on ADHD.
  - The results of the survey will be presented by Heloise Young at the ESCAP Symposia in Strasbourg.
- **Psychotherapy training in child and adolescent psychiatry**
  - This is an upcoming joint project of UEMS, ESCAP and EFPT. Contact has been made to UEMS regarding a survey on national psychotherapy training to be used as background to a guidance paper on psychotherapy in child and adolescent psychiatry

## Future projects

- **Trauma and PTSD**
- Discussion on a German national guideline on trauma and PTSD which could be rewritten as a European guidance paper including representatives from other European countries.
- The guidance paper is planned to be finalized in 2025. Jörg Fegert and Andrea Danese have offered to help with this.
- Finally, we have started to revise the ESCAP webpage on resources. Many of the current resources are 10 years older or more.

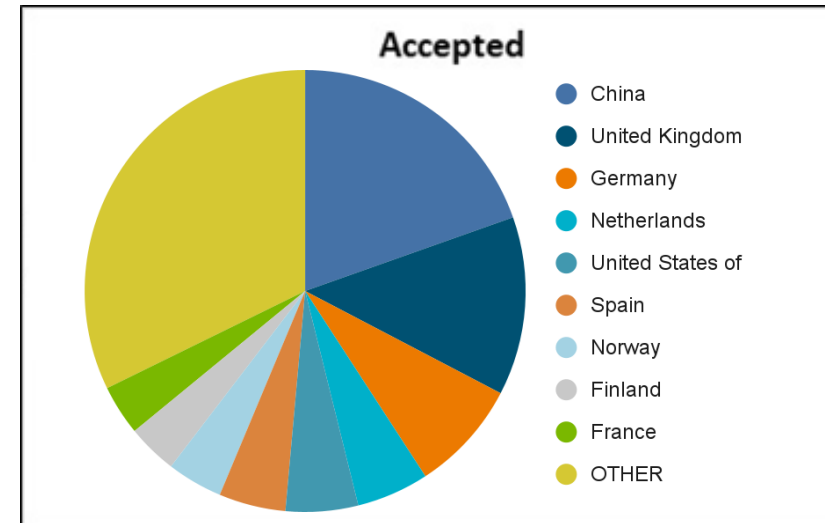
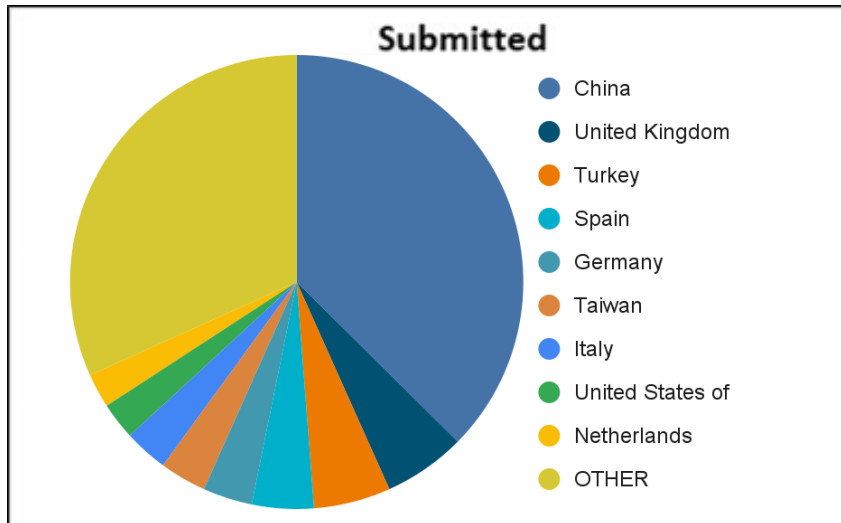
Submissions, acceptances, rejections – 2021-2025-05

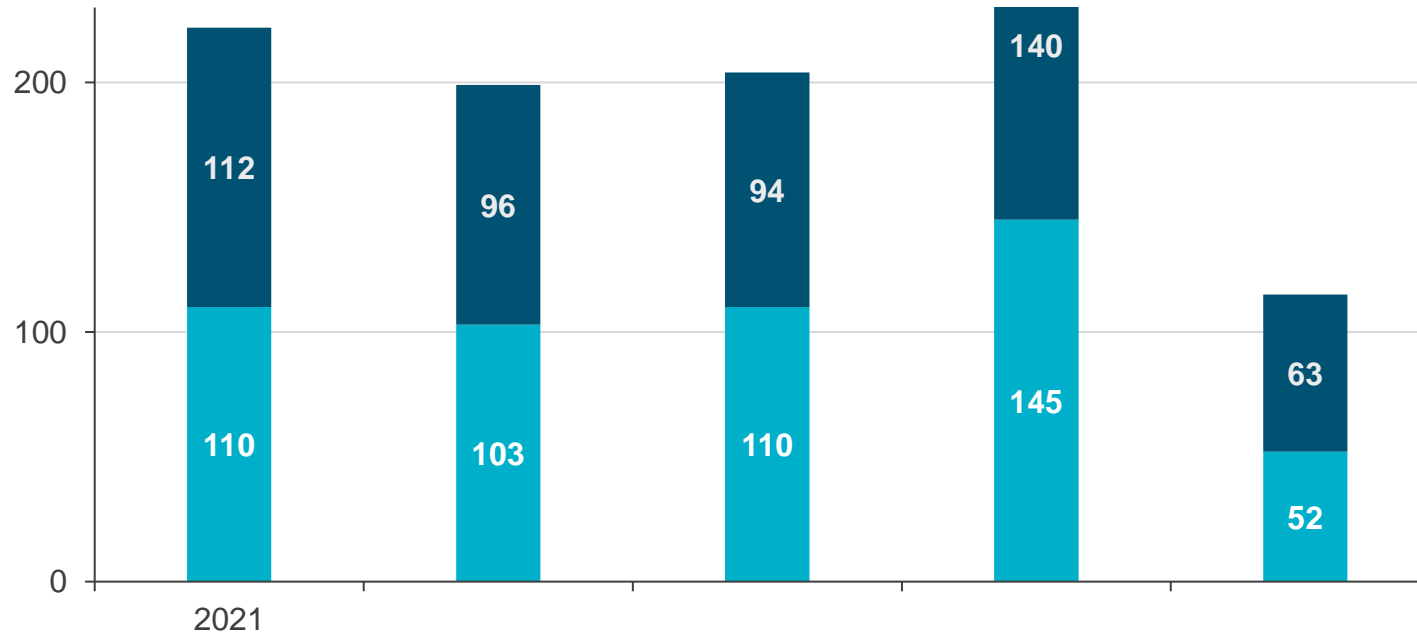

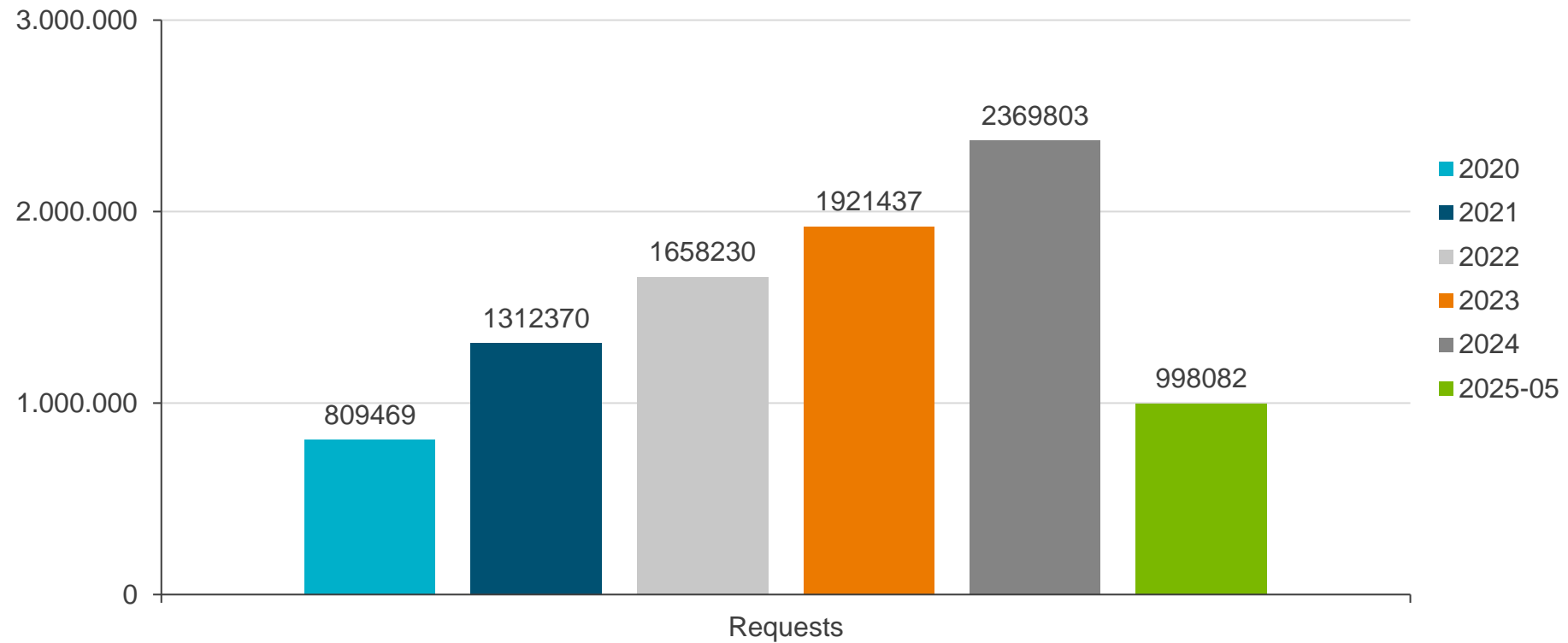

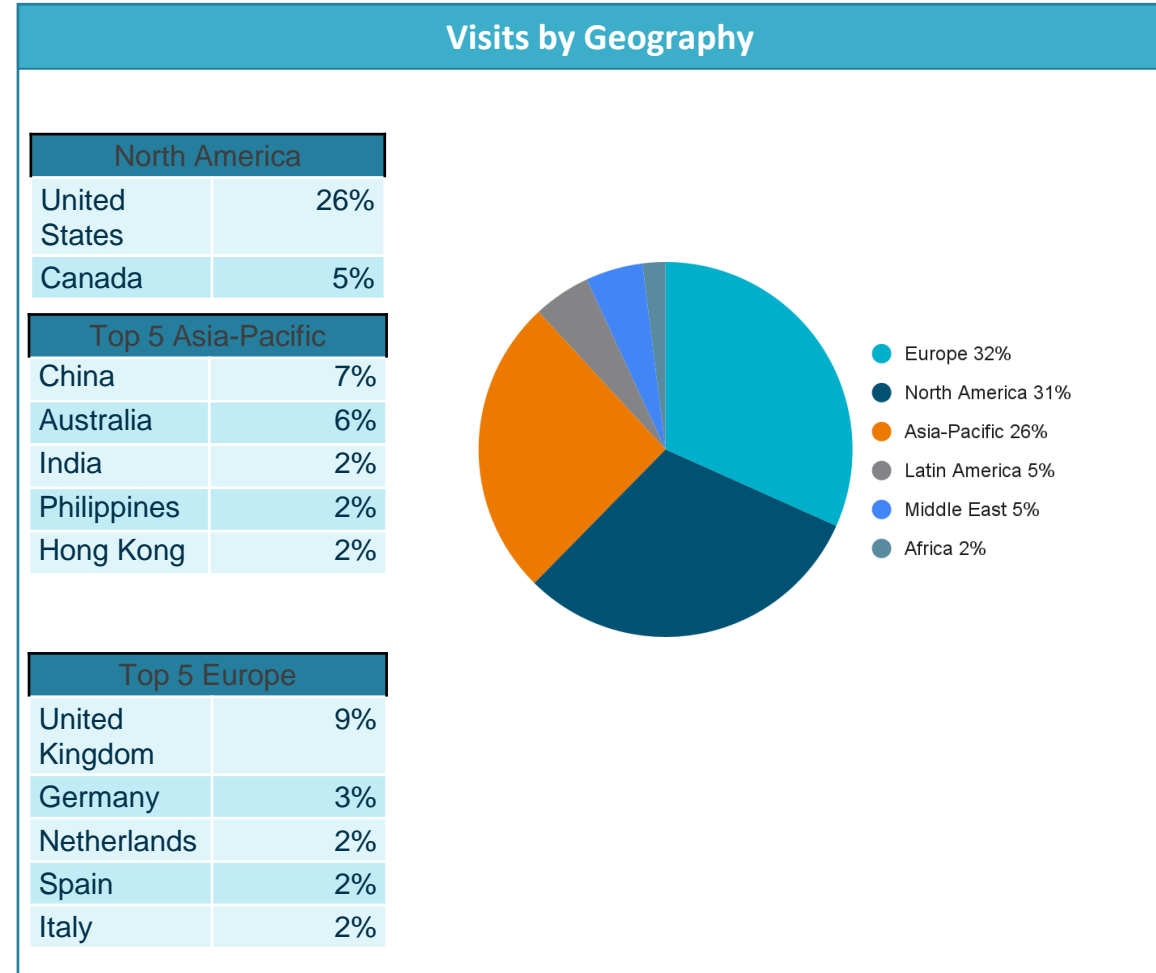

## Visits by Geography (Jun 2024 to May 2025)

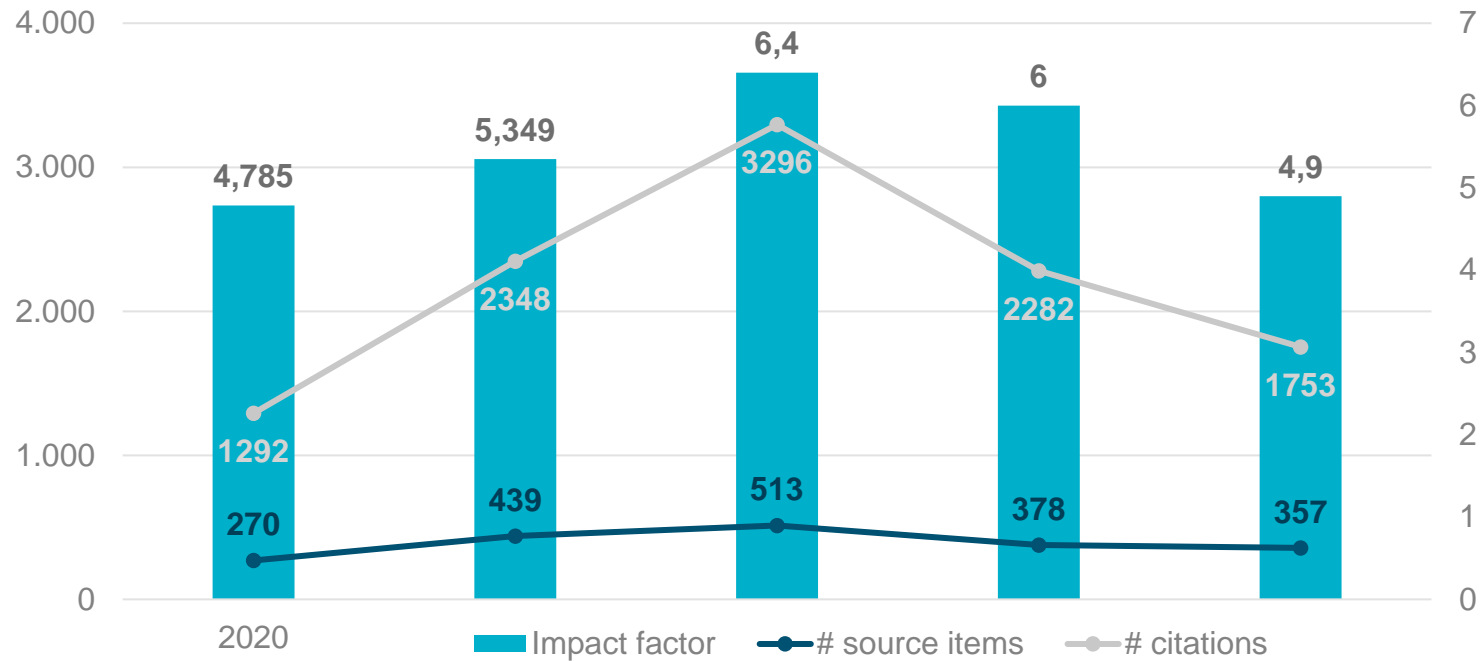

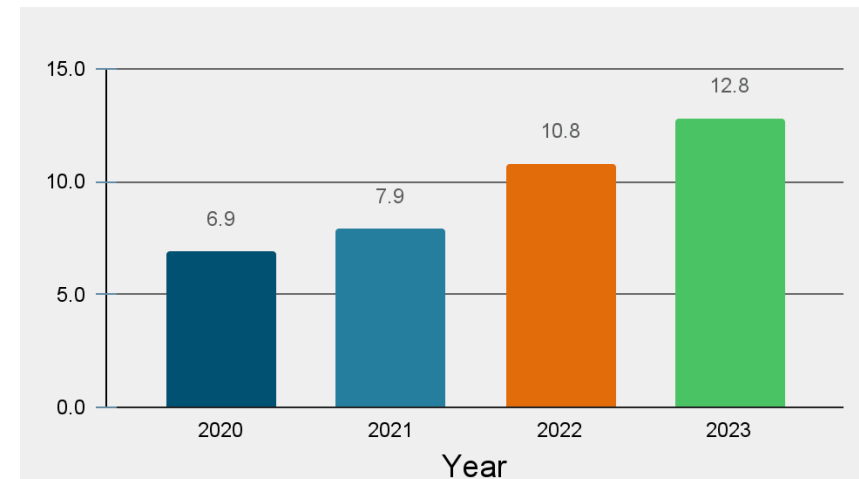

# Comments and perspectives

---



- ESCAP's finances are currently out of balance, with only 8 823 € left in the current account.
  - Income from membership fees is stable. Only two countries have yet to pay their 2024 dues.
  - Costs related to the accounting company are high (approx. 10 000 €/year). We have already received a competing offer from another company for half the price (4,900 €/year).
  - Since 2019, there has been no need to transfer funds from our savings account, which represents approximately a reserve for one year's operation.
  - The 2023 accounts have been submitted and been approved by the Belgian tax office.
  - Our accounts are always in €. Steps are underway to convert them into Swiss francs.
